This is an opportunity to comment on the work of the TACs thus far.
3	6:25-6:45	Bren School Ventura River Watershed Project - Final Presentation Jake Sahl & Naheed Iqbal	Final report on the "Sustainable Water Use in the Ventura River Watershed" project by a team from the UCSB Bren School of Environmental Science & Management. The study sought to identify water management strategies that effectively reduce water demand and increase water supply. A water budget model of the watershed was created using the WEAP (Water Evaluation and Planning) System. This model, combined with economic analysis, was used to assess the impact of water management strategies, land use change, and climate change on local water resources.

A recently developed model for understanding the impact of rainfall cycles on groundwater levels in the Ojai Valley groundwater basin, and associated impacts to flow in San Antonio Creek, will also be described.
