2	6:15-6:25	<b>Watershed Management Plan</b> - Review draft project/program list - Review draft project/program classification framework	The Council's Technical Advisory Committees (TACs) have been developing a comprehensive list of possible projects and programs to be included in the Ventura River Watershed Management Plan, as well as a framework for organizing the projects/programs into meaningful groups. This is an opportunity to comment on the work of the TACs thus far.
3	6:25-6:45	<b>Bren School Ventura River Watershed Project - Final Presentation</b> <i>Jake Sahl &amp; Naheed Iqbal</i>	Final report on the "Sustainable Water Use in the Ventura River Watershed" project by a team from the UCSB Bren School of Environmental Science & Management. The study sought to identify water management strategies that effectively reduce water demand and increase water supply. A water budget model of the watershed was created using the WEAP (Water Evaluation and Planning) System. This model, combined with economic analysis, was used to assess the impact of water management strategies, land use change, and climate change on local water resources.
4	6:45-6:55	<b>Water Supply &amp; Demand Overview</b> <i>Lorraine Walter, Watershed Coordinator</i>	An overview of the watershed's water supplies and water demand.
5	6:55-8:15	<b>A Second Consecutive Dry Winter: Perspectives from Water Supply Managers</b> - Casitas Municipal Water District <i>Steve Wickstrum, General Manager</i> - Ventura Water <i>Shana Epstein, General Manager</i> - Golden State Water <i>Toby Moore, Chief Hydrologist</i> - Ventura River County Water District <i>Bert Rapp, General Manager</i>	The watershed's largest water suppliers/managers will share their perspectives, concerns and ideas about the state of the watershed's surface and groundwater supplies, followed by a group discussion. A recently developed model for understanding the impact of rainfall cycles on groundwater levels in the Ojai Valley groundwater basin, and associated impacts to flow in San Antonio Creek, will also be described.
